IMPORTANT INFORMATION ABOUT A DECLARED CLUB

Who has to declare a bowls club as being their declared club?

It is a requirement under the Constitution of the Gateway District Bowls Association (the **GDBA**) that if you are a member of 2 or more bowls clubs you must declare to the GDBA which club will be your declared club **for championship events that advance to a higher level**.

How do I declare the Belmont Services Bowls Club (the **BSBC**) as my declared club?

Your declaration is made by—

- completing the *Members of Two (2) or More Clubs Declaration* form; and
- giving it to the Secretary of the BSBC, regardless of whether you do, or don't, play championship events.

The Secretary will then forward the form to the GDBA.

What happens when I declare the BSBC as my declared club?

Once you have declared to the GDBA that the BSBC is your declared club, the BSBC will be the only club that you will be able to represent at bowls events when Bowls Queensland is the controlling body for the events.

Championship events are only those events that advance to a higher level, namely A Singles events, A Pairs events and Fours events but **does not** include the GDBA Pennant events.

As a courtesy, please advise the Secretary of the BSBC if you later decide to make another club your declared club instead of the BSBC so that the club's records can be updated.

INFORMATION ABOUT CONCESSIONAL MEMBERSHIP FEE

Who is eligible to claim a concessional membership fee under the club's rules?

The concessional membership fee is available to a person who is receiving a pension. A **pension** means any of the following—

- (a) an Australian Government Age pension;
- (b) a disability support pension;
- (c) a Department of Veterans' Affairs service pension.

The concessional membership fee is also available to a self funded retiree. A **self funded retiree** is a person who—

- (a) is of the qualifying age for a pension; and
- (b) has retired from the work force; and
- (c) has an income other than a pension.
